Estate planning is tough but can make a big difference to the loved ones you leave behind. At Central Trust Company, we help people navigate the planning process. Below are some common questions we receive from clients. We'll cover these topics and more during our Wills, Trusts & BBQ event in June.

### What is an estate plan?

An estate plan is like a roadmap. It directs how you want your personal and financial affairs handled in case of your incapacity or death. People create estate plans for several reasons, including providing support or financial stability to loved ones, minimizing taxes, avoiding problems with loved ones, protecting privacy, preserving wealth and ensuring a person's wishes are carried out.

### I have a will. Why do I need a trust?

A will does not avoid probate. Probate is a costly, time-consuming, and public court process for administering a will. The process includes assembling assets, notifying creditors, paying taxes, and distributing bequests. To avoid probate, some people choose to do revocable living trusts during their lifetime. This ensures your assets are managed if you become incapacitated and avoids probate on death.

### My family members get along. Why do I need an estate plan?

Planning ahead and clearly indicating your wishes alleviates any potential conflict within your family. They can spend time remembering your life and legacy rather than finding and completing paperwork, filing court documents and trying to determine how you would have wanted everything handled.

### What are the components of an estate plan?

- Last will and testament** – Lists property and which people or charities should receive each asset. Names an executor to carry out the terms of your will.
- Revocable living trust** – Controls assets while you're living and distributes them to beneficiaries after death.
- Beneficiary designations** – Avoid probate by naming beneficiaries for your 401(k), IRAs, pensions and life insurance.
- Healthcare power of attorney/Healthcare directives** – Outlines your medical care preferences and names a healthcare agent to make important medical decisions for you.
- Financial power of attorney** – Names a financial agent to make important decisions for you while you're living.
- Insurance policies/financial information** – Gather copies of all insurance policies (e.g. auto, home, health) and bank accounts (e.g. checking account, credit cards, loans).
- Important documents** – Gather your Social Security card, birth, marriage and divorce certificates.
- Titles and property deeds** – Keep record of your titles and deeds for your homes, vehicles and real estate. Be sure to confirm the owners are correct.
- Digital logins/passwords** – Create a list of all digital assets, including logins for your financial accounts, social media, streaming services and photos.
- Funeral instructions** – Provide your preferences for a funeral service and burial.

# Wealth Preservation

## How to Ensure Generational Wealth Lasts

"The Great Wealth Transfer" – Have you

heard of it? Or better yet, will you be a participant in it? The Great Wealth Transfer refers to the trillions of dollars in the United States that the Baby Boomers (those born between 1946 and 1965) and members of the "silent" generation before them (born between 1928 and 1945) are set to transfer to future generations. By some sources, the total intergenerational wealth to change hands will be around \$85 trillion. That's a "85" with TWELVE zeros!

If you find yourself fortunate enough to be within the class of people who will be passing on significant family wealth, you may be wondering how best to transfer assets to the next generation(s) with an eye toward seeing that it lasts and that it is done efficiently from a tax perspective.

## Here are a few things to consider:



### Implement Trusts in Your Estate Plan.

Trusts are the gold standard in the wealth transfer toolbox. A savvy estate planning attorney can explain the different types of trusts and which ones might suit your situation best. A common strategy includes a credit shelter trust to lock in

the applicable estate tax exclusion and the generation skipping transfer tax exemption, while providing income for a surviving spouse.

Another type of trust that often mentioned is the dynasty trust, which, if drafted properly, can spread wealth among generations for years

to come. Trusts are incredibly flexible instruments that can also provide for incapacity and keep matters private – properly funded trusts avoid the hassle, expense, and visibility of probate.



### Deploy the Step-Up in Basis.

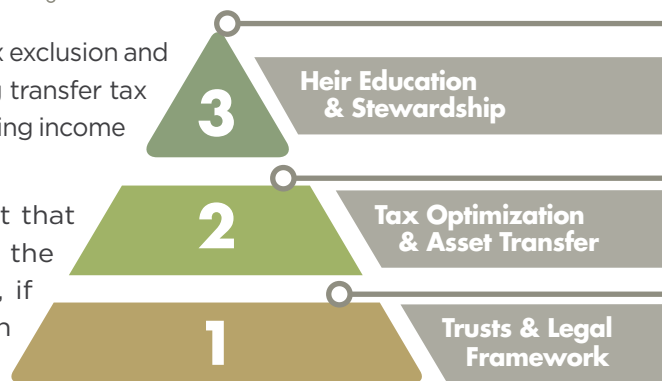
The "step-up" in cost basis is a common method of avoiding capital gains taxes on an appreciated inherited asset. Instead of inheriting the asset at the decedent's cost basis, the asset receives a step-up in basis, to the date-of-death value of the asset at the decedent's death. If the recipient then sells the asset, they will only pay capital gains taxes on the difference between the date of death value and the market value – a huge tax savings.



### Be Wary of Transfer Taxes.

Transfer taxes apply to the transfer of property from one person or entity to another. Gift tax, estate tax and generation-skipping transfer tax all fall into this category. Most people are somewhat familiar with gift and estate tax and are aware of the applicable exclusion amounts (currently \$19,000/year for gift tax; \$13.99 million lifetime exclusion for estate tax), but fewer are aware of the benefits of lifetime gifting versus inheriting at death, or gift-tax free direct payments to medical and educational institutions.

Estate tax planning is generally geared



toward the implementation of various trusts (see above) and tax elections as is generation-skipping transfer tax planning. All of these transfer taxes (along with any applicable state inheritance taxes) should be part of the wealth transfer discussion.



### Educate Your Heirs.

You can only control your wealth for so long, even beyond the grave. Your assets will eventually end up in someone's hands – do they know what to do with them other than spend them? Have you had discussions with your loved ones about money management?

A trust may impose, as a condition of receiving funds, a requirement that beneficiaries take a financial education course or meet with a financial advisor beforehand. You could also include beneficiaries in your annual investment reviews so they can see what goes into the multifaceted development of wealth. Or you could have family meetings where you talk about your goals for your family's wealth and get input from some of those of the X- Y- and Z- generations. You might be surprised to find out what they are thinking!

# HOW TO DETERMINE IF A FINANCIAL ADVOCATE IS RIGHT FOR YOU

Regardless of health status, many people need assistance with managing money as they get older. Here's how to develop a financial plan and choose a financial advocate.

**What is a financial advocate?** A financial advocate is someone you choose to manage money matters, including paying bills, managing property, and handling taxes. A financial advocate may be your spouse, adult child, close friend, or paid professional. It's important to choose someone trustworthy, as they will have a say over your finances. You should have an advocate who understands what matters to you and who will step in if necessary.

## Steps to financial advocacy

The sooner you can plan for the future, the better. A popular age to come up with a financial advocacy plan is around age 65, but don't worry if you're past that age. No matter where you are in the planning process, here are a few steps to implementing a financial advocacy plan.

### 1. PICK A TRUSTED FINANCIAL ADVOCATE

When choosing the right advocate, look for someone who is trustworthy, understands your financial needs, and is reliable. In addition, you need someone who is a smart decision maker, has good communication skills, and is a good listener. Above all, you need someone who will put your needs first.

### 2. ORGANIZE FINANCIAL INFORMATION

When you decide on who will manage your money, it's time to organize and clean up your financial information. Your financial advocate will need to know your sources of income, debt, and other money needs.

### 3. SET EXPECTATIONS WITH FINANCIAL ADVOCATE

Now that you've mapped out your finances, it's time to start a conversation with your advocate and explain what you're needing from them. In addition, this is a good opportunity for the advocate to ask questions and see if they agree to playing the role you need.

### 4. EXPLAIN MONEY MANAGEMENT NEEDS

When your financial advocate agrees to manage your money, it's time to be specific with where your financial information is located and how to access it, and specific requests for how you want your money handled. Your advocate will have a better idea on how to make financial decisions if they understand what is important to you.

### 5. OFFICIALLY APPOINT ADVOCATE UNDER POWER OF ATTORNEY

Before your financial advocate can act on your behalf, they need the legal authority to do so. This happens when they become a financial Power of Attorney (POA). A financial power of attorney is a legal document giving someone else the right to make decisions for you about your money and property.

### 6. MOVE MONEY MANAGEMENT TO ADVOCATE

Now that you've collected all your information and appointed a financial advocate who is now your POA, when is it time for them to manage your

money? Everyone ages at a different pace, so it can be difficult to know when the time is right. Consider working with your advocate to develop a "warning system" for signs it's time. Discuss this plan with your doctor and trusted family, who can alert you if they notice signs it's time to get your financial advocate to help.

Glimpse into Central Park, see St. Paul's Chapel, where George Washington prayed following his inauguration, and view Trinity Church, where Alexander Hamilton was laid to rest. Convene for lunch at New York's most historic tavern, a favorite watering hole among several Founding Fathers. This tavern is where George Washington famously gathered with a group of officers to celebrate after the last British troops left American soil.
