OFFICIAL RULES**

NO PURCHASE, ACCOUNT, OR ZELLE® NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR USING ZELLE® WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: The Summer Better Sweepstakes (the “Sweepstakes”) begins at 12:00:01 AM Eastern Time (“ET”) on Monday, June 1, 2020 and ends at 11:59:59 PM ET on Friday, July 31, 2020 (the “Sweepstakes Period”). There are two (2) Entry Periods as defined in the chart below (“Entry Periods”). Each Financial Institution’s database clock will be the official timekeeping device for this Sweepstakes. Entries must be received according to the chart below to be eligible for that Entry Period drawing. Entries will not be carried over to subsequent Entry Periods.

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who have reached the age of majority in their state of residence (18, except in AL & NE – 19 and MS, 21) at the time of entry and businesses that are located within the 50 United States including the District of Columbia. Void outside the U.S., and where prohibited by law and subject to all federal, state and local laws. Employees of Fidelity Information Services, LLC (the “Sponsor”) US Sweepstakes & Fulfillment Co (the “Administrator”) participating Financial Institutions (the “Financial Institutions”), and each of their respective subsidiaries, affiliates, advertising and promotion agencies (collectively, the “Sweepstakes Entities”), and the immediate family members of, and/or those living in the same household of each, are not eligible to enter or win. Method #1 Zelle® Transaction. To receive one (1) entry via the Zelle® Transaction method, an authorized account holder of a participating Financial Institution will be required to send one (1) Zelle transaction to a recipient using Zelle within the online or mobile app offered by that Financial Institution (the “Zelle® Transaction” method). Limit: one (1) Zelle® Transaction transaction per Zelle recipient per Entry Period. Online and mobile app Zelle transactions must be in the amount of \$5 or more. The date and time of the entry will be the date and time that the transaction is processed. Entries must be complete and received by the end of the Entry Period as described in

chart above to be entered into the associated drawing. Must have a bank account in the U.S. to use *Zelle*.

Method #2: Alternate Method of Entry. Alternate Method of Entry (“AMOE”). To enter without using *Zelle* mail a postcard (the “Mail-In Entry”), including your name, complete address, email address, phone number and the Entry Period you are submitting your entry for to the following address to receive one (1) entry into the Sweepstakes:

PRIZE/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:

Grand Prize: Four (4) Grand Prizes will be available to be won, two (2) for each Entry Period. Grand Prize is \$5,000 that will be awarded in the form of check in the name of the confirmed winner.

The ARV of the Grand Prize is: \$5,000.00 each. The total ARV of all Grand Prizes is: \$20,000.00.

The total ARV of all prizes available to be won: \$20,000.00.

Odds of winning depend upon the total number of eligible entries received for each Entry Period.

LIMIT: one (1) prize per person and per household.

WINNER NOTIFICATION: Grand Prize winners will be confirmed via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, a W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). The Releases will require the winner to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law. Noncompliance will result in disqualification and an alternate winner may be selected.

Prize will be awarded within approximately 45 days after the winner is verified.

If a business is selected as a winner, the prize will be awarded in the name of the business. Owner must provide the business taxpayer ID#.
